Known as Section 9528, the provision is entitled

"Armed Forces Recruiter Access to Students and Student Information" and states the following:

(1) Access to student recruiting information.

Notwithstanding... [20 U.S.C. § 1232g(a)(5)(B)] and except as provided in paragraph (2) [providing that a secondary school student's name, address and telephone number can be withheld upon the parent's request], each local educational agency receiving assistance under this Act shall provide, on a request made by military recruiters or an institution of higher education, access to secondary school Students names, addresses, and telephone listings.

On January 8, 2002, President Bush signed into law the No Child Left Behind Act of 2001. This legislation was enacted to help ensure that every child has the opportunity to obtain a high-quality education in order to reach standards well beyond those that were previously deemed possible.
